## VBA Thumbprint Signature Program Order Form





**Touch Pads** - the pads have a shelf life of 18 months or a minimum of 400 impressions. Banks should order enough for all tellers and drive-through staff.

**Teller Window Display** - banks should post these 6" x 3" "tent-style" display signs at all teller windows as an additional reminder that they participate in the program. The signs read "For the protection of our customers, Thumbprint Signatures will be obtained from <u>all</u> non-account holders seeking to cash checks." (Available in English/Spanish).

**Statement Stuffers**- these 3.5" x 7.5" brochures explain the mechanics of the program. Banks should send them as a public service announcement to all account holders and have plenty available for anyone who might have questions about the program. Please order in increments of 500. (Available in English/Spanish).

**Decals** - banks should post decals at all entrances to let people know they are participating in the program and to warn potential criminals that their crime will not go undetected. Banks may also want to post decals in their drivethru stations. The "peel-off" adhesive decals are 4" in diameter.
