### What is Virginia BankPAC?

Public policy is determined through the political process. BankPAC is your voice through that process. Virginia BankPAC is the Virginia Bankers Association Political Action Committee. Few other industries are as heavily regulated as the banking industry; therefore, it is critical that candidates be elected who support our banking system. BankPAC provides financial support to those candidates. Every year is an election year in Virginia, so it is essential that the VBA be politically involved so that your voice is heard.

### How Does BankPAC Operate?

Virginia BankPAC solicits personal contributions from the employees and directors of member banks of the Virginia Bankers Association. The VBA Government Relations Committee selects candidates to support based on their understanding of our industry, Virginia's banking climate and recommendations from constituent bankers.

### How Do I Participate in BankPAC?

All contributions to Virginia BankPAC can be made in the form of a personal check or credit card payment. Complete the support form and submit it to your bank's Grassroots Coordinator. Contributions to Virginia BankPAC are not tax deductible as a charitable contribution.

#### Giving Formula

VBA BankPAC welcomes contributions of any amount. The following are guidelines to consider in determining your financial support.

Income	Suggested Giving
Up to \$50,000	\$50
\$50,000-\$75,000	\$100
\$75,000-\$100,000	\$250
\$100,000-\$150,000	\$500
\$150,000-\$200,000	\$1,000
\$200,000 and Over	\$1,500

#### Recognition Levels

The Government Relations Committee has established five special recognition levels for individual contributors:

Recognition Levels	Contribution
Diamond Level	\$1,500+
Platinum Level	\$1,000
Gold Level	\$500
Silver Level	\$250
Bronze Level	\$100
