

# External COVID-19 Bulk Ship Testing Availability Program FAQ

# What is COVID-19 Bulk Ship Testing Availability Program?

The COVID-19 Bulk Ship Testing Availability Program provides companies with over 100 employees access to quality, affordably priced OTC (Over the Counter) COVID-19 testing kits from manufacturer Access Bio that can be purchased in bulk directly from Anthem.

OTC CareStart Diagnostic Rapid Antigen Test Kits
FDA EUA (Emergency Use Authorization) for OTC
Includes 2 tests per kit (minimum order required)
Self-administered over age 14
Children between ages 2 and 13 must have test administered by an adult
Results available after 10 minutes but less than 15 minutes; Visually read
Must be stored between 34°F and 86°F and out of direct sunlight

# What are the minimum order requirements?

• OTC Test Kits: minimum order of 464 kits (includes 2 tests per kit) per delivery address

# Is there a maximum number of tests I can purchase?

Anthem reserves the right to ration the number of tests that can be purchased to satisfy paid orders.

# How much do the test kits cost?

# OTC Test Kits:

- \$18.00/kit (includes 2 tests per kit)
  - o 2 boxes (464 kits minimum order) = \$8,352.00
  - 6 boxes (1,392 kits) = **\$25,056.00**
  - 10 boxes (2,320 kits) = **\$41,760.00**
  - Full pallet (4,640 kits) = **\$83,520/pallet**
- Includes freight to single commercial address. For pallet deliveries only, employer must accept deliveries via loading dock or liftgate equipped truck

# What is the shelf life for the test?

6 months. It is important to note that the US Food and Drug Administration (FDA) has recently granted extensions as real-time stability data is realized. We recommend clients limit their order to a 90-day anticipated supply.

# Does Anthem require access to test results?

No. The tests are intended for individual use and Anthem is not involved after the purchase is complete.

# How do I pay for the test kits I order?

An invoice will be sent once the order form has been submitted to Anthem. Please note the order will not ship until payment is received.

# Once the order is submitted, when will I receive an invoice?

An invoice will be sent to the contact on the order form within 2 business days after order is submitted.



#### Does Anthem have a preferred payment method?

Yes. A one-time payment per order via Wire/ACH Credit are the only payment methods. Checks will not be accepted.

#### Can the bulk order program test kits be included on my ASO bill?

No. The only accepted form of payment is Wire/ACH Credit.

#### What is the process if my company is Tax Exempt?

During the initial order form process, the client is prompted to email their Tax Exemption Certificate to taxdepartment@anthem.com. We will not release the invoice until Tax Exemption Certificate has been received.

#### Can unopened test kits/boxes be returned?

No. Due to the nature of these tests, returns are not allowed.

#### Can orders be modified?

Orders cannot be modified after payment has been received.

#### When will my order ship?

Once payment is received, the order will be shipped within 5 business days.

#### How can I track my order?

A confirmation email will be sent from the shipping carrier within 5 business days after payment is received with delivery details. Clients will work directly with the shipping carrier for any modifications or changes to the delivery.

#### Can I pay for expediated shipping?

No. We are only able to accommodate standard shipping as previously arranged.

#### Are there delivery restrictions?

Yes, orders must be delivered to a commercial address capable of receiving freight.

- o For pallet deliveries only, employer must accept deliveries via loading dock or liftgate equipped truck
- o Name(s) and cell number(s) for person authorized to receive the shipment are required

#### Does this testing meet the requirement that is going to be applied for employers with 100+?

Anthem is only providing a bulk purchasing option for testing kits and cannot advise on compliance requirements. More information can be found <u>here</u>.

#### What type of reporting or validation is needed to show compliance with the new requirement?

Anthem is only providing a bulk-purchasing options and is not responsible for how the results are reported to maintain compliance.
